- Do not mix old and new batteries.

Setting up

Connections/Wall mounting

- ① Connect the AC adaptor to the power outlet.
- Drive the screws ((a)) (not supplied) into the wall, if necessary.
 (b) 27.2 mm (1 ¹/₁₆ inches)



Note:

- The AC adaptor must remain connected at all times. (It is normal for the adaptor to feel warm during use.)
- Make sure that the wall and the fixing method are strong enough to support the weight of the unit.


Battery installation/Battery charging

Important:

- Use the supplied rechargeable batteries. For replacement, we recommend using the Panasonic rechargeable batteries noted on page 2.
- USE ONLY rechargeable Ni-MH batteries AAA (R03) size (
- Do NOT use alkaline/manganese/Ni-Cd batteries.
- Confirm correct polarities (⊕, ⊖).

Charge for about 7 hours.

- Confirm "Charging" is displayed (B).
- When the batteries are fully charged, "Fully charged" is displayed.



Note:

 If the batteries are fully charged, but the operating time seems to be shorter, clean the battery ends (⊕, ⊖) and the charge contacts with a dry cloth and charge again.

Registering a handset to a base unit

1 Base unit:

Press and hold **[LOCATOR]** for about 5 seconds.

 If all registered handsets start ringing, press [LOCATOR] again to stop, then repeat this step.

2 Handset:

Place the handset on the base unit or charger, then wait until a long beep sounds and Ψ is displayed.




